In District's original SSIP, which was approved in February of 2017, there was \$60,000 budgeted for 12 (twelve) Smart Tables which were to be installed in VEW Primary School. In planning meetings since the original submission, it was determined that new interactive displays being installed in VEW Primary School would meet the needs of staff and students if adjustable height/tilt brackets were installed in these classrooms. Space is very tight in these classrooms, so making the new interactive displays height adjustable with the ability to tilt them to 45 degrees was a more cost effective and space saving solution. At this time, 9 (nine) of the 12 (twelve) classrooms originally earmarked to receive a SMART table will be going with the adaptable display solutions as opposed to the SMART Table. Therefore, \$45,000 of the \$60,000 originally budgeted for the Smart Tables will be re-allocated to support the STEAM initiatives within the district.

The district is currently in the midst of a major capital project which includes the development of STEM suites in the MS and HS buildings. Both buildings are in the process of revamping curriculum and course offerings for students to create additional opportunities and exposure to STEAM activities.

In DLL Middle School two elective courses have been added to the schedule for the upcoming school year - Innovation Lab and Introduction to Robotics. The Innovation Lab will provide students an opportunity to create products, services, and/or solutions to current problems using a wide variety of resources. Students will have access to maker kits, conventional building trades tools, robotic kits, a 3D printer, a laser engraver/cutter, a CNC milling machine, and VR technology. The new Introduction to Robotics course will provide students expose students to the world of robotics and coding in a variety of mediums. The courses will be run in adjacent spaces in MS library and eventually the connected STEM which will allow for the sharing of resources and components.

The District's approved SSIP submission included a placeholder for the NAO Robotics Kit for \$10,000 in the MS. In the process of researching and developing the MS robotics and innovation lab curriculums it was determined that there are a variety of less expensive and more diverse solutions that afford greater opportunities for students to be exposed to different facets of robotics, engineering, and coding. Therefore, the NAO Robotics Kit will be removed from our submission and kits from Rokenbok, IBM, Cubelets, and OnPoynt will be integrated instead.

The changes highlighted above result in a net reduction of our classroom technologies budget by \$2,605.
